

Summer camp 0- 3 years

For the summer of 2022, parents of children who have attended the municipal or affiliated private nursery schools in the school year 2021/22, can submit the application for admission to the Summer camp of municipal nursery schools, The summer camp will take place in the following shifts:

1. 01 - 15 July 2022
2. 18 – 29 July 2022

The Summer camp is organized in the Headquarters of the following nursery schools :
NIDO IPPODROMO Via Fabio Ricci, 50
I.SANGIORGI/MULINI V. Rasi e Spinelli, 91
NIDO SAN MAURO Via San Miniato, 30
NIDO VIGNE PARCO Via N. Casali, 70

The Summer camp will take place from 7:30 to 16.30, with possibility of intermediate exit from 12.30 to 13.00. Morning breakfast, lunch and afternoon snack are provided.

Families can request one shift o two shifts.

The match to the location of the Summer camp 0-3 years is determined on the basis of the number of received applications and taking into account the nursery attended by each child.

In case of excess applications compared to the available places, the following priority criteria are applied in the formulation of the ranking :

- Condition of disability of the child
- Documented situation of particular family conditions
- Both parents, or lone parent, engaged in work activity

How does it work?

Applications must be submitted during the period indicated in the specific notice published annually.

Applications must be submitted exclusively **online, under penalty of INADMISSIBILITY.**

In case of difficulties in accessing the operating system, the operators of the Help Desk (Sportello Facile) will assist users in completing the online application. For the 2021 Summer camp **applications must be submitted from 15 April to 14 May 2022.**

Applications are accepted even after the deadline and will be evaluated subject to availability.

There is no need to rush for the submission of applications. The scores for the rankings are calculated on the basis of economic and family conditions.

What is needed?

- When submitting the application, parents must indicate their employment situation in the online application form.
Please note that pursuant to art. 445/2000 Administrations are required to carry out appropriate checks on the veracity of the declarations presented

The Administration evaluates any requests for family situations followed by the Social Services

- Holding SPID credentials with a high level of reliability

How much does it cost?

TWO SHIFTS: 2021/22 monthly fee

ONE SHIFT: monthly fee reduced by 25%

No discounts are applied for partial attendance of the summer camp.

The fee paid for the summer camp **cannot be returned** if the child does not attend the summer camp for various reasons
