

Summer camp 3-6 years

The 3-6 years Summer camp of the Municipality of Cesena for the year 2022 is a service for **children aged 3 to 6** (who attended the municipal, state or private kindergarten during the school year 2021/22)

In case of excess applications compared to the available places, the following priority criteria are applied in the formulation of the ranking:

- Condition of disability of the child
- Documented situation of particular family conditions
- Both parents or lone parent engaged in work activity;

The Summer camp will take place in the following shifts:

1. 1 – 15 July 2022
2. 18 – 29 July 2022

Families can request one shift, two shifts (even non-consecutive) or three shifts.

The Summer camp will take place from 7.30 to 16.30, with possibility of intermediate exit from 12.30 to 13.00. Morning breakfast, lunch and afternoon snack are provided.

For 2022 the service is organized at the following municipal preschools:

- SCUOLA FIORITA Via Lombardia, 179
- SCUOLA I.SANGIORGI/MULINI V. Rasi e Spinelli, 91
- SCUOLA IPPODROMO Via Fabio Ricci, 50
- SCUOLA SAN MAURO Via San Miniato, 70
- SCUOLA VIGNE PARCO Via N. Casali, 70

When submitting the application, families can indicate the location in order of preference. The location is assigned in consideration of the places available for each school and of the above mentioned priority criteria. The place for Summer camp is assigned only if the available location was indicated at the time of application.

How does it work?

Applications must be submitted during the period indicated in the specific notice published annually.

Applications must be submitted exclusively **online, under penalty of INADMISSIBILITY** at the following link www.comune.cesena.fc.it/servizionline/scuola using SPID access credentials.

In case of difficulties in accessing the operating system, the operators of the Help Desk (Sportello Facile) will assist users in completing the online application. For year 2022 **applications must be submitted from 15 April to 14 May 2022.**

There is no need to rush for the submission of applications. The scores for the rankings are calculated on the basis of economic and family conditions.

What is needed?

- When submitting the application, parents must indicate their employment situation in the online application form.
Please note that pursuant to art. 445/2000 Administrations are required to carry out appropriate checks on the veracity of the declarations presented

The Administration evaluates any requests for family situations followed by the Social Services

- Holding SPID or fedERA credentials with a high level of reliability

How much?

TWO SHIFTS: monthly fee as indicated in the monthly fees table below

ONE SHIFT: monthly fee reduced by 25%

No discounts are applied for partial attendance of the summer camp.

The fee paid for the summer camp **CANNOT BE RETURNED** if the child does not attend the summer camp for any reason.

ISEE:

Isee can be assessed both for the determination of the monthly fee and for the ranking formulation.

ISEE TO CONSIDER:

1. ISEE 2021 for families who submitted the ISEE 2021 .
 - If the ISEE 2021 is already registered with the Municipality of Cesena, this will be acquired automatically.
 - If the families did not register the ISEE 2021 with the Municipality of Cesena, it is necessary to specify it at the time of application or submit it within the call deadline of 14 May 2022.
2. ISEE 2022 only for families who never submitted the ISEE 2022.
 - If the ISEE 2022 is already registered with the Municipality of Cesena, this will be acquired automatically.
 - If the families did not register the ISEE 2022 with the Municipality of Cesena, it is necessary to specify it at the time of application or submit it within the call deadline of 14 May 2022.
